- Appointment of Annual General Meeting Chair, Secretary, and Scrutineer:
 Moved to appoint General Meeting Chair Kevin Moutray, Secretary Felicia O'Gorman,
 Scrutineer Clay Whitman; carried.
- 3. Approval of agenda: Moved to accept agenda as presented West Coast/Telemark; carried.
- 4. Biathlon BC President opening remarks:
 Welcomed members to the first virtual AGM, and suggested that going forward, virtually connecting could be a beneficial way for BiBC member clubs to meet for learning and season planning.
- 5. Approval of minutes from May 26, 2019 AGM, as posted on Biathlon BC website: Moved to accept minutes as presented West Coast Nordic/ Vancouver Island Biathlon; carried.
- 6. Biathlon BC President report:
 - 6.1. Exciting year with great successes and some challenges.
 - 6.1.1. Many BC athletes competed internationally this season.
 - 6.1.2. Took on the challenge of building a venue for the BC Winter Games (thank you to Tim Roots, Ian Hartley, and Pierre Beaudry for their work on the venue and their time to ensure the Games ran smoothly).
 - 6.1.3. Planned for the first Open Nationals (which were unfortunately cancelled).
 - 6.3. Three new committees with volunteer members working on behalf of BiBC.
 - 6.4. Thank you to the Board members for their work and dedication this year.

- 7. Biathlon BC Treasurer report:
 - 7.1. Presented income statement and reviewed revenue and expenditures.
 - 7.1.1. Comparison of last year to date financial statement to this year to date statement.
 - 7.1.2. Financials in good order, with a net revenue due to the cancellation of Nationals.
- 8. Vice President, Administration and Operations report
 - 8.1. Review of last year's BC Cup competition schedule, coaching and official development.
 - 8.1.1. Waiting for Biathlon Canada to announce its competition schedule (TBA in June), at which point BiBC can then confirm and post its schedule.
 - 8.1.2. Continued focus next year on developing instructors/TDs so that BiBC has more officials around the province capable of teaching training courses and running events.
- 9. Vice President, Program Development report
 - 9.1. Review of last season competitions, camps, and Nationals' planning (prior to cancellation), as well as success of BC athletes racing internationally.
 - 9.2. Information on status of BC athletes on both BiCanada squads and BiBC squads.
 - 9.2.1. Provided information on the hiring of Provincial Coach/Technical Director, explaining how this will allow BiBC to ensure continued success of athletes going forward.
 - 9.2.1.1. Aligning of BiBC's training goals with BiCanada's Gold Medal Profile to allow for cohesive continuity for athlete development between the two sport organizations.
 - 9.3. Peter announced that he is stepping down from the Board this year. He summarized the positive changes he has seen during his time with BiBC, with more focus on athlete and sport development, which has resulted in more success at the National and International level.

 - 10.1.1.2. Cliff Bars will continue supporting BiBC at Cup events, and Case Place will provide discounts on Pelican rifle cases.
 - 10.1.2. Working on developing digital marketing strategic plan.
 - 10.2. Currently not pursuing any sponsorships due to the financial constraints on businesses brought on by the Covid pandemic.

 - 11.1.1. Athlete Rep met with BC athletes online to get feedback on the season.
 - 11.1.1.1. Athletes provided feedback on what they thought were positive aspects of the season (a well spaced race schedule, with few conflicts with XC races), and offered

suggestions on how next season could be improved (more 1 on 1 coaching, incentives to go to Nationals, early season race, and more head to head races).
