- 1. Call to order 7:02 p.m.
- 2. Approval of agenda Aaron/Gary, carried

- 4. Old Business
 - 4.1. Status update on Gaming Grant requirements to increase club membership. Lynn will follow up with Black Jack and Kevin will contact Ft St John. Both clubs were contacted and there was no response.
 - 4.2. Biathlon BC Strategic Plan working group update. Will address the transition challenges for postsecondary athletes. Full day meeting will be held April 11th, 2021 at 9am to draft.
