- 9. General Manager Report. Roddy Ward provided his report on the previous season summarizing BiBC's athlete performance, growth initiatives, coaching and officials' development, and events.
- 10. Committee Reports. Ian Hartley presented a summary for the Officials Development Committee, outlining the activities and courses provided during 2023/24, along with proposed actions and courses for the next year. Roddy provided a summary on behalf of the Competition Committee, detailing race attendance and timing data collected. He also outlined the upcoming season's races and discussed potential collaboration between Biathlon Canada and Biathlon Alberta to increase competition and event size, aiming to make races more profitable. Additionally, Roddy summarized the Marketing Committee's report, which highlighted current sponsorships.
